## **WHO/Bill Gates depopulation program in Kenya**

In 2014, the WHO, with its largest funder Bill Gates, conducted a „tetanus vaccination“ program in Kenya. Soon after, a team of doctors discovered the jabs contained something they were not supposed to contain-sterility causing hormonal substances.

### **The tetanus vaccination campaign**

The official goal of the 2014 WHO/UNICEF/GAVI (Global Alliance for Vaccines and Immunization) vaccination program in Kenya was to eradicate neonatal tetanus. Tetanus is a disease caused by the *Clostridium tetani* bacteria, present in the soil. The vaccine is based on tetanus toxoid substance. With adults, the shots are usually administered in 1 or 2 doses, with boosters every 10 years.

What first struck the Kenyan doctors was the number of doses – 1 every 6 months over a period of 2 years – which is not a standard for tetanus vaccination. Also, the fact that only women of childbearing age (15-49) were vaccinated, not men.

Soon after the campaign took place, medical researchers were informed by the Kenya Catholic Doctors Association about sterility causing agents in the shots.<sup>1</sup>

After that claim, three accredited biochemistry labs in Nairobi tested samples of the vaccine – only to find out that it contained Human Chorionic Gonadotropin hormone (hCG) - something that should not be present in a tetanus vaccine.

Once administered through the jab, the woman's body reacts to hCG by developing antibodies to it and then rejects any pregnancy as soon as it starts growing in her womb.

The same year, 6 more samples of the vaccine were sent to another 6 accredited labs in South Africa. Half of the samples again contained hCG.<sup>2</sup>

*“We sent six samples from around Kenya to laboratories in South Africa. They tested positive for the hCG antigen,”* stated in a bulletin Dr. Muhame Ngare of the Mercy Medical Centre in Nairobi. *“This proved right our worst fears; that this WHO campaign is not about eradicating neonatal tetanus but a well-coordinated forceful population control mass sterilization exercise using a proven fertility regulating vaccine.”*, he continues.

The doctors noticed other unusual features of the program. Instead of being distributed by the local medical centers, the WHO jabs were conducted at the luxurious New Stanley Hotel in Nairobi, with a police escort accompanying the shots to the vaccination sites, where police officers supervised their handing.

In 2015, the Kenyan Catholic Doctors' Association accused the WHO, UNICEF and GAVI of rendering millions of women sterile. In 2019, a group of independent researchers led by University of British Columbia neurologist Dr Christopher Shaw concluded that *„Laboratory testing of the TT vaccine used in the WHO Kenya campaign 2013- 2015 showed that some of the vials contained a TT/βhCG conjugate consistent with the WHO’s goal to develop anti-fertility vaccines to reduce the rate of population growth, especially in least developed countries such as Kenya”*. And confirms the Catholic Doctors conclusions: *„...our opinion is that the Kenya “anti-tetanus” campaign was reasonably called into question by the Kenya Catholic Doctors Association as a front for population growth reduction.,<sup>2</sup>*

### **The sad history of experiments on people in the Developing world**

It wouldn't be the first time the world health agencies conducted horrifying „philanthropic” experimental programs in Third World countries.

In 1991 an experiment of the drug Nevirapine, targeting HIV-infected mothers, took place in Uganda. It caused the loss of health and lives of many mothers and their children.<sup>3</sup>

In 2000 Gates launched a polio vaccination program in India. The resulting vaccine derived poliovirus – a mutation of the virus contained in the jab - paralyzed 491 000 children.<sup>4</sup>

In 2012, the Indian government canceled Gates from their advisory board.

In 2008, the WHO launched an experimental program of the new Pentavalent vaccine in Bhutan, Sri Lanka and Vietnam. It is produced by the Serum Institute of India, whose owner is a friend of Bill Gates. For safety reasons, this vaccine was not approved by the FDA for use in the US. In Bhutan, 9 babies died until the government suspended the program. The same happened in Sri Lanka, where 19 babies died soon after the start of the program. In Vietnam, 27 infants died before the government suspended the program.

In 2009, Gates funded experimental trials on girls in India, to test the HPV vaccine Gardasil. Many children fell ill and 7 girls died after being administered the shot. After that, widespread criticism of Bill Gates began on Twitter in India with the #ArrestBillGates.<sup>5</sup>

In a 2024 interview with LinkedIn founder Reid Hoffman, Gates brags that India is “a kind of laboratory to try things.”<sup>6</sup>

It is no secret that the former Microsoft founder is today one of the largest investors in pharmaceutical companies (Pfizer, Merck, GlaxoSmithKline among others). Through the Bill and Melinda Gates Foundation (BMGF) – WHO's largest donor - he can influence the sale of his vaccines. The WHO in return conducts experimental vaccination programs for the companies where Gates is invested. This strategic alliance, disguised as "philanthropy", allows him to promote his investments, and to carry on with his experiments on new vaccines.

Human trials for new immunizations are not easy to perform in the West. That is why the Third World is a dream come true for the Pharma industry, where the rule of law is low, and the most vulnerable people can be used almost without any fear of liability for the pharma companies. Serious adverse events, or even deaths, are rarely reported. Since most African countries were left bankrupted by the IMF loans, they rely solely on international assistance to tackle their health programs. It has thus become a habit for the BMGF/WHO to test their vaccines in Africa – using Black people as guinea pigs.

However, in view of the presence of hCG in the Kenya shots, we may argue that the program was not about testing a new vaccine, but an experiment about sterilization possibilities. Why? A little less well-known fact is that Mr. Gates is a big proponent of eugenics.

### **What is eugenics?**

Eugenics is a pseudoscience promoting the idea that some human beings are inferior to others, and that by altering their reproduction, the genetic quality of the population can be improved. In the USA it was put into practice in the beginning of the 20<sup>th</sup> Century, with the grants of the Rockefeller foundation. Soon, sterilization of the „unfit“ was supported by US state laws. For instance, in 1909 California was the 3<sup>rd</sup> state to adopt laws requiring sterilization of intellectually challenged Americans. Campaigns involved pursuing and sterilizing people seen as feeble-minded, poor or with other mental or physical disabilities, or ethnic minorities. In total, about 70 000 Americans were sterilized in the 20<sup>th</sup> century. The majority were women.

In the 1930's, the Rockefeller Foundation sent huge donations to German researchers, including those conducting Adolf Hitler's studies. As Hitler mentioned: „*Now that we know the laws of heredity, it is possible to a large extent to prevent unhealthy and severely handicapped beings from coming into the world.*“<sup>7</sup> The Nazis soon developed eugenics to a higher level. As Joseph DeJarnette, superintendent at Virginia's Western State Hospital and proponent of eugenics, mentioned: „*Hitler is beating us at our own game.*“<sup>7</sup>

Today, Bill Gates, through his BMGF, walks in the footsteps of the Rockefeller Foundation.

To understand Gates's passion in eugenics, we have to go back in time. William H. Gates I., Bill's father, was a passionate proponent of eugenics, and since 1914 a member of the American Eugenics Society<sup>8</sup> and a member of Planned Parenthood. Founded in 1916 by the racist eugenicist Margaret Sanger, this organization promoted the sterilization and the purge of "human waste."<sup>9</sup>

In 1939, Sanger created the racist Negro Project. As she stated in a letter to her eugenic colleague, Clarence Gamble (founder of Procter and Gamble): "We do not want word to go out that we want to exterminate the Negro population, and the minister is the man who can straighten out that idea if it ever occurs to any of their more rebellious members".<sup>10</sup>

It is obvious that little Bill was shaped by his father's beliefs in the cleansing of the unpure race - that is, mostly, non-Whites. During his speeches, Bill Gates mentioned many times his concerns about the reproduction rate in the developing world and the need to regulate it.

### **WHO's long history of birth-control „vaccines“**

The idea of sterilisation vaccines is not new. The WHO has been developing a birth control vaccine since the 1970's, and in 1976 WHO researchers reported they created a birth-control shot. WHO publications don't try to hide that the agency's long-term purpose is to reduce population growth in Third World countries. Researchers had conjugated tetanus toxoid (TT) with human chorionic gonadotropin (hCG) producing a "birth-control" vaccine. Conjugating TT with hCG causes pregnancy hormones to be attacked by the immune system. Expected results are abortions in females already pregnant and/or infertility in recipients not yet impregnated. WHO publications show a long-range purpose to reduce population growth in unstable less developed countries.<sup>2</sup>

In 1974, WHO and USAID worked jointly on the top-secret Kissinger Report, which outlined the necessity for "reducing fertility to near zero in less developed nations".

In 1993 and 1994, the WHO conducted other antifertility vaccination programs in Mexico, Nicaragua and the Philippines. In these countries, women of childbearing age were told by the WHO that they were being vaccinated against neonatal tetanus.

In 2015, the Gates Foundation promoted, for Pfizer, the self-injecting contraceptive shot Depo-Provera. Its side effects are so high that in the US the law requires it to have the Black Box warning. Adverse effects: fatal bone loss, missed periods, excessive bleeding, blood clots in arms, legs, lungs and eyes, stroke, weight gain, depression, hair loss, permanent infertility (Producer's leaflet). Its largest marketer, Planned Parenthood, specifically targets Black and Latino women (84 % of its users in the US are Blacks). Gates first tested it in Ghana, in partnership with the Rockefeller foundation - telling the recipients they were receiving regular routine healthcare. In 2015, Gates planned to distribute Depo-Provera to 120 million women in the world's poorest countries. In the US, because of its side effects, the shot can only be administered by a clinician. To circumvent this „problem“ for its mass distribution in Africa, Pfizer and Gates used a cunning trick – handing over the shots under the Gates Foundation, thus protecting themselves from liability and lawsuits.

4 years before the campaign in Kenya, Gates, in his talk in California, bragged that new vaccines can help reduce the world population growth. The same year, he pledged to donate 10 billion dollars to the WHO for the implementation of new vaccines in the Third World.<sup>11</sup>

All evidence points out that the WHO in partnership with the Bill and Melinda Gates foundation put once again their birth-control vaccines into practice in Kenya in 2014.

### **Kenya's push-back against the WHO**

In October 2024, Kenya granted immunity privileges to the Bill and Melinda Gates Foundation.<sup>12</sup> This status gave the foundation's officials immunity while conducting its operations. This decision sparked public controversy, and in a November 25 2024 ruling the High Court of Kenya prohibited any members of the Bill and Melinda Gates foundation from continuing to enjoy any privileges and immunities from prosecution.<sup>13</sup>

## Final thoughts

Thanks to the sterilization vaccines masqueraded as tetanus shots, hundreds of thousands of Kenyan women won't be able to have children anymore. Yet the sterilization experiment conducted in Kenya is just the tip of the iceberg of a dark agenda.

The world health institutions have been privatized by billionaires who believe they have the right to decide on human life and death. We can only hope that Kenya's termination of Gates' immunity is the start of an awakening to the overreach of these unelected global elites, operating under the guise of philanthropy and public health.
